

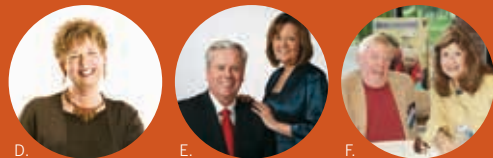
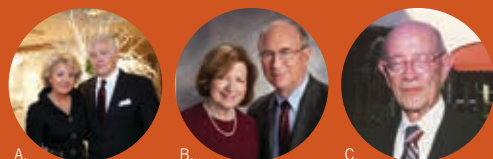
Mary Day Society
