# Celebrate the Plate FAQs



#### What is the Celebrate the Plate event?

CELEBRATE THE PLATE started in 2014 and is a fundraising event for the Women's Board that helps the Women's Board to provide services and fund programs for Akron Children's, in support of its mission to provide medical care to infants, children, adolescents, and burn victims of all ages in our community regardless of ability to pay.

The 9th annual Celebrate the Plate will be a hybrid event and commences on Wednesday, May 1, 2024, with a Kickoff event held in the Considine Lobby from 6:30 pm to 8:30 pm. Hosts will be able to have their desired event (dinner, porch party, tennis round robin, etc.) between May 1st and May 31st at their chosen time and venue. It is the host's choice to hold an open or closed event and to determine the date, time, theme, and location.

### What is the difference between an Open and Closed Celebrate the Plate event?

An Open party will accept RSVPs from a mailed invitation. For example, John Smith is hosting a themed dinner party of Tuscany Under the Sun. He has room for 16 guests. Since this is an open party, John Smith's party will be listed in our Celebrate the Plate invitation that will be mailed in March. Those invitees will choose their top three choices of an event to attend. When John Smith's party fills up with 16 guests, the party will be closed to further attendees. John Smith can also provide a list of guests that he would like to invite as part of his allowable seats.

A closed party is restricted by space, type, and number of attendees. For example, tennis or pickleball round robins, Euchre or bowling party. These types of parties are limited due to venue and are determined by the host.

### What is the responsibility of the host?

A host will determine the five W's of When, What, Where, Who, and What.

When: the party date and time

What: the type of party

Where: the location of the party

Who: the invite list. If closed, the host will be responsible for providing invitations to their

attendees

What: support Akron Children's by committing to a minimum \$1,000 donation

The \$1,000 donation is the minimum we ask the host to commit. This donation can be fully paid by the host OR split among the guests. For example, Jane Doe is hosting a tennis round-robin. On her invite, she has listed a suggested player's fee of \$100 and any other donation will be accepted. The fee determined by the host will go towards the minimum donation requirement. Therefore, Jane will meet her \$1,000 minimum donation with just 10 players.







The CTP committee will provide a QR code and donation box for each host. If an attendee chooses to donate at the event by check or cash, the host will agree to record these donations including name, address, check, or cash to enable tax letters to be generated. The donation boxes will be collected by a committee member at a mutually agreed-upon time following each event.

One additional requirement of each host is to play a short highlight video message featuring Akron Children's President and CEO Chris Gessner and the presenting James Beard Sponsor.

## What is the ticket sale procedure?

Tickets will be sold for open events by reservation only. Invitations will be sent out in March and invitees will select their top three choices of destinations they would like to attend and will be assigned on a first-come, first-served basis. Attendees will be notified of the destination prior to the event.

For closed events, tickets will not be sold by the Celebrate the Plate Committee. The host will be responsible for RSVPs.

#### What is the Host Coordinator?

The Host Coordinator will assist you throughout the process with any questions or concerns. The Host Coordinator can help determine the type of party, menu planning and be a liaison if needed for your event.

Our Host Coordinator for the 2024 Celebrate the Plate is Cecilia O'Donnell and she will be in contact with each Host once they decide to host a party.

#### Do you provide publicity pre and post-event?

For Open events, publicity will be through both printed invitations and Women's Board Channels (Instagram, Celebrate the Plate website).

For Closed events, publicity will be through Women's Board channels (Instagram, Celebrate the Plate website).

Please advise if you have any concerns regarding publicity. We will not provide addresses of events until RSVPs are confirmed for open events.
